




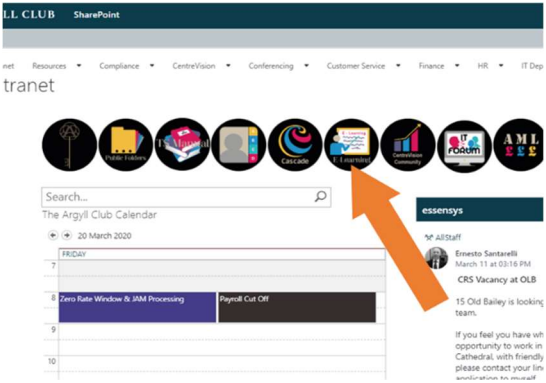
ONLINE LEARNING OPPORTUNITIES

Our employees have the ability to continue completing their health and safety training and other developmental training courses via our *eLearning portal – Safety Media*.

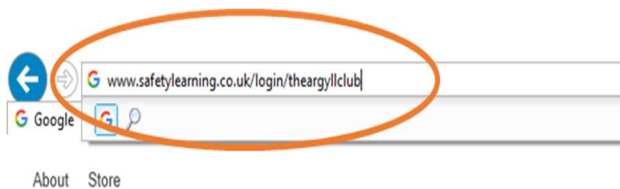
This only requires Wi-Fi, an internet connection and your work login to access content by using a company-issued phone/laptop or a personal phone/mobile device.

Here are some instructions how you can access the learning platform from a personal smart phone/laptop or device.

Instructions to login to Safety Media

<p>1.</p> 	<p>Connected your device to the Wi-Fi.</p>
<p>2.</p> 	<p>If you are using a work device – laptop or phone, you can access the elearning platform as usual, via Sharepoint.</p> <p>You will need to approve the sign in request on their authenticator app.</p> <p>The, click on the ‘ELearning’ circular icon.</p> <p>This should take you directly to your personal training list. See point 5.</p>

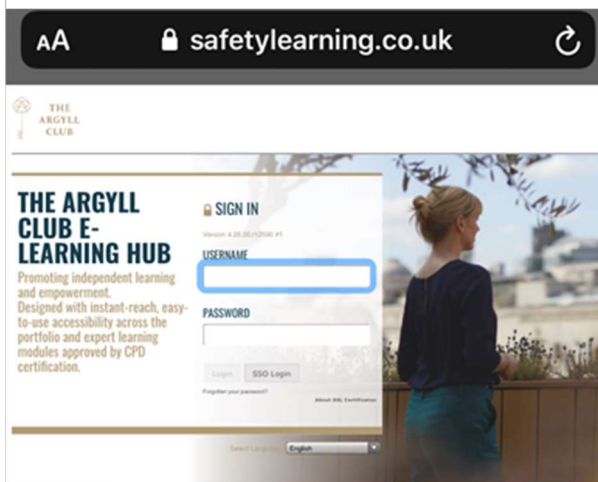

This will be your personal work email address (firstname.surname@theargyllclub.com)

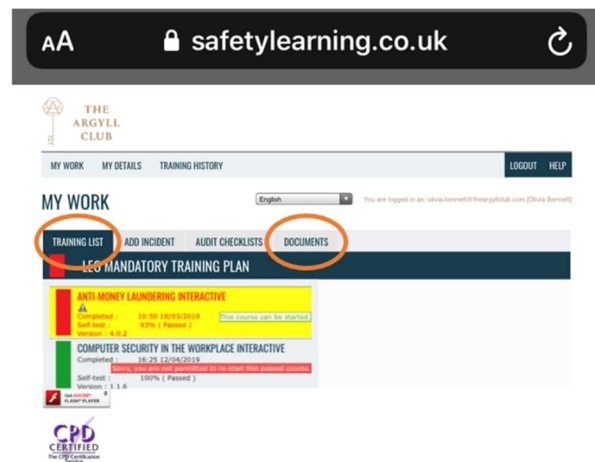
The **Password** will be either:

Learning opportunities that can be accessed

For those who are remote working, these two courses are mandatory courses to be complete:

- **Health and Safety for Homeworkers (Employees)**

Course Overview: this interactive course is designed to raise awareness of the risks and hazards that are prevalent within the home-based workplace. Users will receive informative advice and guidance and will be tested on their understanding of the subject at the end of the course by completing the compulsory self-test.

Duration: 25-30 minutes.



- **DSE (Display Screen Equipment)**

Course Overview: This module covers, the different types of DSE, potential hazards and risks with DSE, keeping your workplace safe, using portable DSE and understanding how simple stretches can help you.

Duration: 30-35 minutes.
